ORDINANCE NO. <u>1-106</u>-3

AN ORDINANCE OF THE VILLAGE OF CHAMBERS, NEBRASKA, ESTABLISHING SALARIES FOR THE VILLAGE BOARD MEMBERS, PROVIDING AN EFFECTIVE DATE, AND REPEALING ALL CONFLICTING ORDINANCES.

BE IT ORDAINED BY THE VILLAGE BOARD OF THE VILLAGE OF CHAMBERS, NEBRASKA, AS FOLLOWS:

SECTION 1. That the salary of the chairman of the Village Board shall be \$1,500.00 per year. The salaries of the other board members shall be \$1,200.00 per year. Such salaries shall be paid monthly and shall become effective September 17, 2025.

SECTION 2. In addition to the salaries set forth above, the members of the Village Board shall be entitled to reimbursement of their expenses in attending village-related functions requiring out of town travel.

SECTION 3. All ordinances or parts of ordinances in conflict are hereby repealed.

SECTION 4. This ordinance shall be effective from and after its passage, approval and publication as required by law.
